Vendor Lots

Lots will come equipped with a tent w/ 4 walls, tables, and chairs.

- ***Note that you must rent the TOTAL amount of space needed including any room needed for a Pod, Teching, Vehicle, Display Racks, Signage, etc.***
- ***If you want a 20 x 20 SPACE but just a 10 x 10 tent, you must notify us on this application.***
- ***Do not assume our crew will know what type of set up you require or expect unless it is in writing below.***
- ***If you use up any space outside the lot you are renting, your credit card will be charged accordingly.***
- ***You will not have space behind your compound, so be sure to that factor in when selecting your lot size.***
- ***Specific locations such as “corner spots” are not given out.***

Vendors will be required to sign-out with PSP on all rental equipment used during the event and be billed directly for any losses or damages. All 10 x 10, 10 x 20 and 10 x 30 tents will be PSP branded.

Conditions

- 1) All vendors are required to notify PSP of special promotions at their booth. PSP reserves the right to disallow any promotion or event that it deems inappropriate for the presentation of our sport to the public.
- 2) PSP reserves the right to modify any aspect of this vendor agreement in order to satisfy specific contractual obligations or restrictions within the venue.
- 3) Vendors may not sublease their booth space and cannot merge any other product lines into their booth unless they are an exclusive dealer of that product.
- 4) PSP will give reasonable notice for any required logos, ads, or information needed to help promote the vendor.
- 5) Booth space is limited at each of our events. It will be available on a first come, first serve basis according to balances paid. Only paid vendors will be confirmed for the event.
- 6) Paint distribution rights are reserved for our Platinum and Gold sponsors and may not be sold through any other size booth.
- 7) **All applications must be submitted no later than June 2, 2011.**

*Also, please note that all vendors will be required to carry general liability insurance for the event which names both Paintball Sports Promotions LLC and PSP Events LLC as additionally insured. Proof of insurance must be emailed to camille@pspevents.com or faxed to (248) 869 6023 no later than June 2, 2011.

Indemnification

Vendor shall defend (if required by PSP), indemnify and hold PSP, and the officers, directors, agents, employees and assigns of PSP (collectively the "Indemnified Parties"), harmless from and against any and all claims, demands, suits, damages, liabilities, losses or expenses of any nature whatsoever (including, without limitation, attorneys' fees and costs) arising from or relating to: (a) any act or omission of Vendor, its officers, directors, agents, sub-contractors, employees, invitees, or sponsors (collectively, the "Involved Entities"); (b) a breach of any term or covenant contained herein by the Involved Entities; (c) any advertising or signage installed or authorized by the Involved Entities, if any; (d) any advertising, promotion, sale or other distribution of kind; and/or (e) the use by the Involved Entities of any medical services, including ambulance services, in connection with Vendor's activities or any Event relating to this Agreement regardless of whether such services were obtained through or provided by PSP. The provisions of this paragraph shall survive, indefinitely, the expiration or sooner termination of this Agreement.

Important Information Regarding 2011 PSP Events

1. You are renting a lot from the PSP

What happens inside that lot is your responsibility. You have no rights to utilize the space outside of your lot. There will be parking for your vehicle in the parking lot, not at your lot, unless it is inside your rented space and a part of your set up/display. The PSP must be notified in writing on this agreement should you need power, extra chairs, tables, etc. We do not carry an extra supply of these goods at the events.

You will not have space behind your compound, so be sure to that factor in when selecting your lot size. *If you were planning on having a pod or storage container shipped to the event for example, you must rent a lot size large enough to contain that pod.* Specific locations such as “corner spots” are not given out.

2. Shipping

PSP only ship out freight, not packages through UPS, Fed-Ex, etc. *Any Shipments coming in from such carriers **should be delivered TO YOUR HOTEL**, not to the event venue.* The Shipping Address is listed on the last page of this agreement. Shipments may not arrive before the Monday prior to the event.

All shipments must be picked up the Monday following an event. Vendors are responsible for providing the shipping company with all necessary information including but not limited to: address, company name, contact name and phone number. PSP will be in no way responsible for shipments being picked up or left beyond the given pick-up date.

3. Move-In/Move-out

Trucks can start arriving on Monday June 20th and need to be offsite by Tuesday June 28th. Vendors setting up their own tents must have the tent up by noon on Wednesday June 22nd (can start as early as Tuesday June 21st.) All tents that we supply will be ready by Tuesday June 21st. *All booths should be open with set-up completed by noon on Wednesday, June 22nd.*

4. Storage Units

PODS will be allowed onsite but vendor must notify PSP of drop-off time for the unit as well as pick-up time on the Monday following the event at least two weeks prior to the event. PSP will reserve the right to have the drop-off times changed as necessary for a smoother set-up process onsite.

5. Security

Overnight security will be provided at all PSP events throughout the season. If a vendor wishes to hire additional security for either day or night, they will be required to go through the company contracted by PSP.

*Also, no camping or sleeping onsite at any event will be allowed unless otherwise noted.
